On the above date and time, I, Officer Carl Michael Williamson, was at Catahoula Court with a total of 15 offenders. While watching these offenders, Pre-trial offender Jeffery Tyler Coleman (ID#2023060101), could have slipped out while I was escorting another offender to the court room. I was away from the holding room door for approximately 30 seconds. I was also talking to Logan Massey, Lawyer, about offenders Marty Cagle and Ronald Baxter. I could see the holding room door. The only time I took my eyes off the holding room door was when I was escorting offenders from the holding area to the court room door. This took approximately 30 seconds for each offender that was on the court list. After offender Jeffery Tyler Coleman left the holding room, offender Robert Johnson requested to speak with Lawyer Paul Lemke. When Mr. Lemke came in to speak with offender Johnson, the offender told Mr. Lemke that offender Jeffery Tyler Coleman had left out of the holding room. Mr. Lemke then told Officer Johnny Nelson. Officer Nelson and I went into the holding room together and started a roll call of the offender. At this time we realized that offender Coleman was not present in the holding area. Officer Nelson then contacted Captain Spinks and told him that offender Jeffery Coleman had escaped. Catahoula Parish Sheriff's office was immediately notified and assisted in the search for Offender Coleman.
