ON THE ABOVE DATE AND APPROXIMATE TIME, I LT. WHITTINGTON WAS CALLED TO CONTROL 1 BY THE CONTROL 1 OPERATOR (OFC. SHELBY FORD) REGARDING OFFENDER 6) TRYING TO CHECK OUT OF A-DORM. UPON ARRIVAL TO A-DORM AS OFFENDER C WAS COMING OUT OF THE DORM I LT. CORY WHITTINGTON NOTICED THAT OFFENDER CH HAD BLOOD ON HIS SWEATER ON THE BACK LEFT SHOLDER. I LT. WHITTINGTON THEN ESCORTED OFFENDER N. TO MEDICAL FOR FURTHER MEDICAL EVALUATION. DURING THE MEDICAL EVALUATION I LT. WHITTINGTON NOTICED OFFENDER CHATMAN HAD TWO FAIRLY LARGE STAB WOUNDS TO THE BACK LEFT SHOLDER AREA. I LT. WHITTINGTON HAD SGT. DONNA HARDIE HELP MYSELF LT. WHITTINGTON IN CLEANING THE WOUNDS ON OFFENDER CH. ONCE BOTH MYSELF LT. WHITTINGTON AND SGT. HARDIE GOT THE BLEEDING TO STOP AND THE WOUNDS WERE FURTHER LOOKED AT. I LT. WHITTINGTON THEN CONTACTED THE SHERIFFS OFFICE ABOUT GETTING AN AMBULANCE IN ROUTE FOR POSSIBLE TRANSPORTATION FOR OFFENDER CH. COL. SAVAGE AND MGR. WATHEN WAS ALSO NOTIFIED ABOUT THIS SITUATION. AT APPROXIMATELY 16:01 PM TRANSPORTATION OFC. WHITE AND RANDELL WAS IN ROUTE TO LASALLE GENERAL HOSPITAL WITH OFFENDER CH TO LASALLE GENERAL HOSPITAL. I LT. WHITTINGTON THEN WENT TO CONTROL 1 TO REVIEW THE CAMERAS. AFTER CAREFULLY REVIEWING THE CAMERAS I OBSERVED OFFENDER F (7331) WALK PAST THE TABLE AREA AND AROUND TO THE PHONE AREA WHERE OFFENDER CH WAS ON THE PHONE. OFFENDER DU CAME UP BEHIND OFFENDER C AND ATTACKED HIM WITH AN IMPROVISED WEAPON (SHANK) STABBING OFFENDER CHATMAN IN THE BACK TWICE. THIS ACTION FROM OFFENDER RICH (7331) PUTS HIM IN DIRECT VIOLATION OF RULE #11 AGGRAVATED FIGHTING. OFFENDER WAS PLACED INTO CELL #2 TO AWAIT DISCIPLINARY ACTION. EOR

Title: INVESTIGATION REPORT

On 5/5/24 I began investigating a stabbing incident that occurred at the Catahoula Correctional Center between inmates. Inmate [redacted] was stabbed in the left shoulder and was transported to the emergency room for treatment.

During the investigation, video footage show that C [redacted] was on the phone in the dorm. Inmate [redacted] walks up behind him and begins stabbing him with an improvised weapon (shank) several times. While investigating the offense, it was learned that C [redacted] was receiving stitches to the two wounds at the emergency room.

On 5/14/2024, I prepared an arrest affidavit and arrest warrant for R [redacted] for the charge of Aggravated Battery. The affidavit and arrest warrant was presented to Judge Kathy Johnson. After review, Judge Johnson signed the warrant ordering the arrest of [redacted].

On 05/21/2024, [redacted] was arrested and booked on the charge of Aggravated Battery. He was then transported back CCC pending a court hearing. EOR
