UPON ENTRY, I WASN'T ABLE TO LOCATE THE OFFENDERS INVOLVED IN THE <sup>altercation</sup> LOCATION, HOWEVER, OFFENDER WRIGHT, TREVIONNE (#618160) WAS IN THE SHOWER. I TOLD WRIGHT TO STEP OUT OF THE SHOWER, AND I WAS ABLE TO SEE THAT OFFENDER WRIGHT HAD WHAT APPEARED TO BE STAB WOUNDS ON THE TOP OF HIS HEAD. I REMOVED THE OFFENDER AND TOOK HIM TO MEDICAL FOR EXAMINATION BY L.P.N. WANDA PARKER, WRIGHT WAS CLEARED AND PLACED IN CELL #2 PENDING FURTHER INVESTIGATION. I BEGAN TO REVIEW CONTROL #4'S CAMERA (**J-DORM LEFT**) AT (10:26:59) AND SAW THREE OFFENDERS ASSAULT WRIGHT. OFFENDER MORRISON, JERELL (#782772) AND OFFENDER ENCLADE, JEROME (#601346) SNUCK BEHIND WRIGHT AS HE HAD HIS BACK TURNED TO WALK TOWARD THE SHOWER OF J-DORM, THE TWO THEN PLACED A CHOKEHOLD AROUND WRIGHT'S KNECK AND BEGAN TO LIFT THE OFFENDER OFF OF HIS FEET TO BE CARRIED TO THE REAR OF J-DORM. IMMEDIATELY, OFFENDER MCDANIEL, DEDARIUS (#751687) BEGAN STABBING WRIGHT IN THE TOP OF HIS HEAD MULTIPLE TIMES. THE ALTERCATION THEN CEASED, AND OFFICERS RESPONDED; ALL OF THE ABOVE LISTED OFFENDERS INVOLVED WERE TAKEN TO MEDICAL FOR EXAMINATION, CLEARED BY L.P.N. WANDA PARKER AND PLACED IN SEPARATE CELLS, PENDING FURTHER DISCIPLINARY ACTIONS. E.O.R...
