ON THE ABOVE DATE AND APPROXIMATE TIME, I CPT. CHRISTOPHER BARLOW OBSERVED ON CAMERA OFFENDER LEON ALLEN (546698) STEAL OFFENDER ENYEL BELLO URBINA (782828) CLOTHES AND BLANKETS. AT THIS TIME OFFENDER ENYEL BELLO URBINA NOTICED OFFENDER LEON ALLEN HAD STOLE HIS PROPERTY AND WENT TO OFFENDER ALLEN. BOTH OFFENDERS ALLEN AND URBINA START FIGHTING. WHILE FIGHTING OFFENDER ALLEN STABBED OFFENDER URBINA. AT THIS TIME OFFENDERS STOPPED FIGHTING THEN OFFENDER URBINA GRABBED A BROOM AND HIT OFFENDER ALLEN AND OFFENDER ALLEN AND URBINA STARTED FIGHTING AGAIN. THEN OFFENDER SANDRO AVILA SOSA (745065) CAME RUNNING AND STABBED OFFENDER ALLEN IN THE STOMACH AREA. OFFENDER ALLEN THEN FELL TO THE GROUND AND OFFENDER SOSA STARTED STABBING OFFENDER ALLEN WHILE OFFENDER ALLEN WAS ON THE GROUND. AT THIS TIME OFFENDER LOUIS SCOTT (620304) CAME UP AND HIT OFFENDERS URBINA AND OFFENDER SOSA TO BREAK UP THE FIGHT. ALL OFFENDERS WERE TAKEN TO MEDICAL AND OFFENDER ALLEN WAS SENT TO LASALLE HOSPITAL. OFFENDER URBINA SUFFERED SEVERAL STAB WOUNDS BUT NONE WERE LIFE THREATNING AND WAS TREATED BY NURSE WANDA PARKER. OFFENDER SOSA AND URBINA WERE PLACED IN CELL-8 AWAITING DISCIPLINARY ACTION FOR RULE# 11 AGG. FIGHTING. OFFENDER SCOTT WAS PLACED IN CELL-12 AWAITING DISCIPLINARY ACTION FOR RULE# 10 FIGHTING E.O.R.

Title: INCIDENT/ARREST REPORT

On 6/02/24, the Catahoula Parish Sheriffs office received a call from the Catahoula Correctional Facility reporting that they had a incident where an inmate had been stabbed and was going to be transported to the hospital for emergency care.

During the investigation, it was learned that inmate Leon Allen had stolen an item from inmate Enyel Bello-Urbina. Bello-Urbina then began to fight with Allen. Allen used and improvised cutting instrument to cut Bello-Urbina during the fight. At this time, inmate Sandro Avila-Sosa came into the fight and stabbed Allen twice with a improvised weapon. Bello-Urbina was also hitting Allen at this time with a broom handle. Allen received severe injuries during the incident. He was transported to the emergency room for medical treatment where it was found that he had a collapsed lung from one of the stab wounds. He was admitted into ICU due to the severity of the injuries and the unstable condition. Bello-Urbina was brought to the prison medical unit for treatment for the minor wounds he received and didnt require to be sent to the emergency room. (See video footage of the incident)

On 7/8/24, arrest affidavits and warrants were prepared against Avila-Sosa and Bello-Urbina for Aggravated Battery and Possession of contraband ion a penal institute.

On 7/9/24, the documents were presented to Judge Kathy Johnson for review. After review, Judge Johnson signed the documents, ordering the arrest of both above listed suspects for the presented charges.

On 7/18/24, Avila-Sosa and Bello-Urbina were arrested at the Catahoula Correctional Facility for the charges of Aggravated Battery and Possession of contraband in a penal institute. They were transported o CPSO for booking. Once booking was complete, both suspects were returned to CCC to await prosecution.
